STREAM	SUBJECT OFFERED	CRITERIA
COMMERCE	English, Business Studies, Accountancy, Economics, Physical Education & Applied Mathematics / Hindi / Bengali	Students must have passed in their Class X Board Exam with minimum of 65% marks in aggregate. In case the student is opting for Applied Mathematics , he/she must have secured a minimum of 80% marks in Mathematics in Class-X Board Exam .
HUMANITIES	English, History, Geography, Economics, Physical Education & Political Science / Hindi / Bengali	Students must have passed in their Class X Board Exam with minimum of 60% marks in aggregate.

- Payment of Registration fee will be accepted only through debit / credit cards. Kindly note that the registration fee is non-refundable.
