## NOTICE

1. With reference to the order dated 06.08.2021, passed by the Division Bench of Hon'ble High Court of Calcutta in W.P.A (P) No.162 of 2021 in *Rajib Chakraborty & Ors. vs. The State of West Bengal & Ors.*, and connected matters whereby the Hon'ble High Court of Calcutta, has interalia passed the following directions;

*"Keeping all these factors in mind we pass the following order:*

- (i) Each of the schools and other teaching institutions covered by this public interest litigation shall within a week from date send to each defaulting parent or guardian the outstanding as of date from March, 2020 in terms of the order of this court dated 13th October, 2020 read with the subsequent orders.*
- (ii) Within three weeks from date at least 50% (fifty per cent) of the claimed amount should be paid, irrespective of any dispute with regard to the claim of the school. Any dispute regarding the claimed amount is to be resolved later.*
- (iii) If on the returnable date of this application there is any default this court will consider the following courses open to it:*
  - (a) Permit the schools and teaching institutions to suspend the instruction to the students in all forms, on line and physical.*
  - (b) Remove the name of the students from the roll of the school without further notice.*

*(c) For those students who have taken the school final or higher secondary examination and qualified, a direction is to be made to the respective Boards to suspend their qualification and certificates till the school fees are paid."*

2. In view of the aforesaid order, all parents/guardians defaulting in payment of outstanding fees, are requested to clear the due fees of their wards on or before 31<sup>st</sup> August 2021, to avoid reporting to the Hon'ble High Court of Calcutta with regard to non compliance thereof.

That the present notice will not be applicable on the parents/guardians of the students, who have already paid 80% of the fee for the academic year 2020-21, as per **Annexure I** of the notice dated 31<sup>st</sup> October 2020 (in compliance with direction (ii) of the order dated 13.10.2020), however **this would not include** the parents/guardians, defaulting in payment of outstanding fees for the academic year 2021-22.
